→ Economic Outlook

• Czech Economy Outlook in 2001

The Czech Center and the Consulate General in New York hosted the 2nd Czech Business Breakfast Meeting on March 8, 2001 with Marie Bohata, President of the Czech Republic's Statistical Office. Ms. Bohata focused on the current state of the Czech economy and important economic indicators in her speech, as well as the forecast for the Czech economy in 2001.

In 2000, the growth of GDP (2.8 percent) was higher than estimated. Manufacturing showed a swift growth of 6 percent, partly due to the revival in the machinery industry, and partly due to the success of Czech exports and growing household consumption. The fastest growth was recorded in the telecommunications sector because of the flourishing cellular phone market.

The Czech Statistical Office estimates that construction will be the fastest growing sector in 2000, followed by retail. GDP growth is expected to be between 3 and 3.5 percent. Ms. Bohata also noted that agriculture contributes 5 percent to GDP, while industrial output contributes 42 percent and services 52 percent. Hence, the share of industrial production on the total output is already 5 percent above the usual average level in economically developed countries and an increase of investment in the service sector would be desirable.

• Bilateral Trade: Czech Republic - United States

According to the U.S. Department of Commerce, Czech exports of \$1,071 million to the United States and imports of \$733 million from the United States resulted in a U.S. trade deficit of \$338 million. In 2000, Czech exports grew 42 percent compared with the previous year, while U.S. exports increased 20 percent. Total volume of U.S.-Czech trade increased 32 percent. Among the major Czech articles exported to the U.S. were electrical machinery (29 percent), machinery (21), glass and glassware (7), organic chemicals (4), and furniture and bedding (3). U.S. exports to the Czech Republic were

dominated by aircraft (24 percent), machinery (22), electrical machinery (16), optical and medical instruments (9), and tobacco (6). The fastest growing Czech exports in 2000 were electrical machinery (110 percent increase against 1999 value), iron and steel products (88), iron and steel (71), art and antiques (71), machinery (68), and railway and traffic sign equipment (59). U.S. exports grew in the categories of: art and antiques (585 percent increase against the 1999 value), rubber (217), chemical products (120), wood (91), edible fruit and nuts (59), and aircraft (44).

- **First Pennsylvania Trade Mission to Czech Republic, Poland, Hungary - May 8 through 18, 2001**

- **Past Event: InWest Forum Central Europe, New York**

More than 300 representatives from US businesses attended the InWest Forum Central Europe Conference, held at the World Trade Center in the financial district of New York City on February 26, 2001. The event highlighted the vicinity of the Czech Republic, Hungary, Poland, and Slovakia as a region that forms a strategic hub for foreign direct investment. The full auditorium signaled the growing interest of U.S. businesses in Central Europe. Deputy Prime Ministers of the represented countries, U.S. Ambassadors to the countries, and representatives of the U.S. enterprises active in the region (General Electric, U.S. Steel, Coca-Cola and others) shared their views on the prospect for foreign business in Central Europe. Mr. Robert Rubin, former Secretary of Treasury, delivered an encouraging speech at the conference luncheon.

Mr. Pavel Mertlik, Czech Deputy Prime Minister and Minister of Finance of the Czech Republic stressed the sound and stable economic development in the Czech Republic. He also noted that the transparent legal environment for business, along with the EU accession process and the newly implemented investment incentive package by the Czech government, are main attributes of the recent influx of FDI to the country. In his closing remarks, Ambassador of the Czech Republic Alexandr Vondra said, "I believe that the interim period before the Czech Republic and other countries of Central Europe join the EU is an historically unique period of paramount importance for foreign investors. I urge the U.S. companies not to miss this unique period of time and to include Central Europe into their global strategies."

→ Companies & Market

- Prague has become the "Hollywood on the Vltava River," according to Economist and CNN reports. Last year, Hollywood spent over \$200 million shooting movies, commercials and pop videos in the Czech capital. Not only are Czech crews professional, English-speaking, and abundant, they are also a bargain at 40 percent cheaper than similar crews in Los Angeles or London. The biggest draw to Prague is Barrandov - one of the largest film studios in Europe with 11 sound stages, on-site photo labs, and top-notch technicians. Prague itself is a ready-made scene for contemporary and historic films. This year, all of the big studios will be in town, including MGM with "Hart's War," starring Bruce Willis and Disney with "Black Sheep," starring Anthony Hopkins. Fox just recently finished filming "From Hell." The Prague and Los Angeles based company, Milk and Honey Films has been instrumental in leading Hollywood to Prague.

- CSA Czech Airlines, the Czech national carrier, completed a very successful year in 2000. The airline quoted a positive economic growth rate, which can be illustrated by the almost 20 percent increase of carried passengers, as compared to 1999. Their total revenue reached almost CZK 17 billion, compared to 13.5 billion crowns the previous year. Last year's results are even more valued, due to the negative impact of fuel prices and the unfavorable exchange rate of the Czech crown against the dollar. The utilization of CSA aircraft increased 6 percent and can be compared to the world standard, which fluctuates at around 70 percent. Czech Airlines has a fleet of 28 aircraft dominated by Boeing and ranks amongst the newest in the industry with an average aircraft age of six years. The last Russian TU-154 aircraft were removed from service and replaced by the new Boeing 737 aircraft at the beginning of 2000.

- Ingersoll Rand Co., the U.S. manufacturer of non-electrical machinery and equipment, began building a new plant for automobile component production in the Czech City of Olomouc in February. The investment will reach \$19 million and create 350 new jobs. Olomouc was selected because of its highly skilled labor force. Based in Woodcliff Lake, New Jersey, Ingersoll Rand employs 46,000 people worldwide and has an annual revenue in excess of \$7 billion. The company was granted investment incentives.

- Dura Automotive CZ, the Czech subsidiary of the U.S. company Dura Automotive Systems, is building another plant for automobile components production in Blatna. Dura will invest

\$16 million and plans to employ an extra 200 people within the next three years. The construction of the plant has been endorsed by investment incentives and should be completed by the end of 2001. The new plant will produce doorframes and other components for Ford and Audi cars. Dura Automotive Systems is a leading supplier of door modules, glass systems, seat mechanisms and structures. Dura Automotive Systems headquarters in Rochester Hills, Michigan, and employs more than 21,000 people in 80 facilities worldwide.

- Arrow International CR, the Czech subsidiary of the U.S. company Arrow International, is building another plant for medical equipment production (catheters) in Hradec. Arrow International will invest \$11.5 million. The plant will create 230 new jobs, while the total number of employees will reach 600 people. The new plant is expected to begin production in November 2001. Arrow's first production plant, built in 1994, was the first U.S. greenfield investment to receive investment incentives.

- Eastman Chemical Co., the U.S. manufacturer of chemicals, fibers, and plastics, intends to expand its acryl acid production capacity in its Czech subsidiary Chemické závody Sokolov (CHZS). The project's completion is expected in 2002. Eastman Chemical is based in Kingsport, Tennessee and employees 16,000 people worldwide. The company's annual revenues exceed \$4 billion.

- Trustfin-Vanguard, a joint-venture established by the Czech company Trustfin and the U.S. knitting machine manufacturer Monarch is beginning to manufacture new medium-diameter knitting machines using a new method of technology. The company will invest \$11 million and plans to create 200 new jobs within the next three years. There are only two more companies in the world producing such machines at this time - Santoni and Sangiacomo from Italy. The development of the new machine only took one year. Trustfin-Vanguard is based in the Czech city of Vsetin and received investment incentives.

- Five Czech-made streetcars are being delivered to Portland, OR by the trading firm Inekon Group and the manufacturer Skoda. The streetcars will be commissioned in the City of Portland on Independence Day 2001. Another three streetcars for Tacoma, WA will follow the first delivery of tramways by Skoda, valued at \$12 million. Skoda Transportation Technique Co. has 700 employees and belongs to Skoda Holding, Pilsen.

The company also builds and upgrades locomotives and subway trains.

- ETI Inc. in Baltimore, MD, is completing an assembly of electric trolley buses made by the Czech manufacturer Skoda Ostrov, to be commissioned in San Francisco. The first new trolley buses will be tested in the streets of San Francisco this April. According to the contract, more than 250 Czech-made trolley buses will be commissioned in the city within the next several years.
- The Czech government has agreed to grant incentives to IBM to invest CZK 359 million (\$9.6 million) in an information technology service center in the Czech Republic. According to comments made by Industry and Trade Minister Miroslav Gregr at a press conference, the center would be built in Brno, the Czech Republic's second largest city. Brno is the country's regional high-tech and information technology hub, located 125 miles south-east of Prague. The IBM service center will create 200 new jobs. Minister Gregr also said that the company will get incentives in the form of tax breaks and training subsidies, but did not place a nominal figure on the extent of the support. The government has developed and recently improved a system of incentives in order to lure foreign direct investments into the Czech Republic to modernize Czech industry and services, and accelerate economic growth.
- The Czech cabinet is to consider a proposal that would allow foreign firms to purchase real estate in the CR. The measure would apply to all foreign companies, including those who do not have their headquarters in the country. Czech-based companies or subsidiaries already have this right.
- U.S. Precision Castparts Corp. has started producing components for Rolls-Royce aircraft engines in its new plant in the industrial zone in Pilsen, where it has installed cutting-edge technology. The facility will employ 300 people.
- Japanese automotive headlights manufacturer Koito Manufacturing announced that it would build a new greenfield facility in Zatec, Czech Republic. The plant will supply 2.6 million headlights for Japanese and European car manufacturers. Koito qualified for tax incentives, including job grants and tax breaks.
- As the Czech Republic strives to become the No. 1 investment destination in Central Europe, another two large Japanese industrial companies have settled into the country. Electronics manufacturer Mitsubishi Electric Corporation and bearings manufacturer Koyo Seiko Co. will create a joint venture to build power steering parts. According to the Czech government investment agency CzechInvest, the two companies plan to invest one billion crowns (\$26 million) into a factory in the Czech town of Slany, located 33 kilometers northwest of Prague. This investment will bring yet another car parts manufacturer to the Czech Republic, a country which has already attracted scores of auto industry investors for both greenfield projects and acquisitions, including Volkswagen AG's takeover of Skoda Auto. In the first nine months of last year, the Czech Republic attracted \$2.9 billion in foreign direct investment. The new venture between Mitsubishi Electric and Koyo Seiko, called "Electronic Power Steering Components Europe," will have a basic capital of CZK 500 million (\$13 million). Mitsubishi Electric is one of the Japan's five big chip-makers. Koyo Seiko produces electric power steering and controls a large portion of the international market for the device.
- Skoda Auto plans to launch a large car model later this year or early next year, as well as open a new engine and transmissions plant. The plant will supply 500,000 engines per year for the Volkswagen group. CEO Vratislav Kulhanek told press that the new car, which will be an addition to the current small-sized Fabia and mid-sized Octavia lines, would help Skoda achieve its mid-term sales target of 600,000 cars

annually. Though the final name for the new car is not yet known, Skoda presented a prototype with the name Montreaux in Geneva, Switzerland.

- The Czech power-engineering supplier Skoda Energo has sealed a contract with the Slovak Instroenergo Group and the Turkish Tekfen Co. to deliver a 180 MW power station in Turkey. The value of supplies provided by Skoda will reach more than CZK 5.8 billion, making the contract one of Skoda Energo's largest. Since 1999, Skoda Energo, part of Skoda Holding, has restructured its operations, leading to a 37 percent productivity increase. With 2,400 employees, the company's turnover reached over CZK 3 billion last year. Supported by the consulting firm A.T. Kearney, the parent company Skoda Holding is looking for a strategic investor to sell its electric engineering and transformers division.
- U.S. Zy-Tech Global Industries Inc., one of the world largest companies dealing with industrial valves, intends to buy a share in MSA -- the leading Czech manufacturer of industrial valves and fittings. MSA has a long tradition of industrial valve production and ranks among the major world producers of low-emission valves and supplies gate valves, swing-check valves, ball and globe valves, expansion joints and special valves to oil and gas transport, distribution and processing, conventional and nuclear power plants, water pipelines, heat production and distribution.
- Head Co. intends to expand its facility in Ceske Budejovice (Budweiss), Czech Republic, in order to manufacture skis in addition to its current tennis racket production.
- The Czech glass fibers processing company Vertex Litomysl reported record sales (up 50 percent) and profit increases (up 143 percent). Vertex is a leading European manufacturer of textile processing glass fibers. Its manufacturing program includes woven roving fabrics, thermal insulation fabrics, wall coverings, fabrics and tapes for reinforced plastics, and mesh fabrics for civil engineering.
- Technology Distribution and Austrian SaT System Integration have taken over NEOS, one of the largest Czech IT companies. NEOS is a safety system integrator that employs over 160 people.
- Tractor manufacturer Zetor Brno was "back in the black" at the end of 2000, after a 19-month period of difficult company restructuring. Since reopening its production line in October 2000, Zetor manufactured and dispatched 600 tractors to 22 countries. The Zetor tractor is a highly popular imported tractor in the United States, with sales reaching up to 2000 units a year.
- Last year, the main Czech breweries concentrated more on quality by awarding quality certificates to restaurants and pubs that served their beer properly. The Czech people remained the world's top beer drinkers in 2000 with average annual consumption exceeding 160 liters per capita, even though prices of bottled premium beer rose 10.3 percent. The excellence of Czech brewing is confirmed by the increase of exports overseas. Last year, the value of Czech beer exports to the United States exceeded \$8 million with Pilsner Urquell being the dominant Czech brand in the U.S. market.

→ Focused on: Agriculture in the Czech Republic

• Introduction

According to a legend, after many years of wandering across Europe, the first Czech tribes arrived in the fertile lands of Bohemia and decided to settle there, in what they described as "The Promised Land -- flowing with milk and honey."

The Czech Republic is self-sufficient in terms of food production. Farming contributes significantly to total Czech exports, whereas cereal cultivation represents the most important branch. Winter wheat is cultivated on roughly a quarter of all arable land. The second most important cereal is barley, which is used for the production of high-quality malt.

The cultivation of sugar beet and the production of sugar are traditional branches of Czech agriculture and food industry. Between the World Wars, Czech sugar refineries produced 6 percent of the total world output of sugar and up to 20 percent of the European output. The cultivation of the sugar beet is concentrated in the warmest and most fertile areas of central and eastern Bohemia and Moravia.

Over the last decade, the demand for healthier and less expensive vegetable oils has significantly risen, beginning the expansion of oil-plant farming. Most of the produced rape-seed is industrially processed into edible oils, fats, and bio-oil. Nearly half of the 1 million tons of rape-seed production is exported to EU markets. Expansion of the non-food use of rape seed, including its use in technical bio-lubricants and in an ecological fuel known as "bio-oil," is expected in the future. The domestic production of mustard seed and poppy seed is destined primarily for export to foreign markets. Czech varieties of hop and technologies of hop cultivation have become the basis for European and world hop growing. The Czech Saaz hop has

been recognized as an international standard for quality and remains exceptional for its fine aroma.

Grapevines are cultivated in the wine regions of both Bohemia and Moravia. The Czech Republic produces a wide range of individual types and varieties of wines, from table wines to those of high quality, or special-label wines. The most common varieties of white grapes are the Veltlin Green, the Muller Thurgau, and the Italian Riesling. The most abundant varieties of red grapes include the Svatovavrinec and the Frankovka. The high-quality output of wine is exported to many countries.

Fishpond breeding focuses on the traditional Christmas carp, representing 90 percent of overall fish production in the Czech Republic.

The newly restructured Czech food industry is making efforts to implement a system of critical points in production (HAACP) in order to reach the EU hygiene and veterinary standards, and to introduce systems of quality control in line with ISO 9000 standard and other international norms.

The Czech Republic's traditional export items include beer and brewing materials and semi-finished products, dairy and meat articles, vegetable fats and oils, sweets and chocolates, food treatment products, diet snacks, smoked smallgoods (i.e. Prague sausages), and spirits (Becherovka liqueur, gin, rum, vodka, and whiskey).

In 2000, the U.S. Department of Agriculture concluded that the Czech Republic has adequate effective sanitary and food safety controls to ensure that their meat products comply with the relevant U.S. standards and are safe to be exported.

→ Travel Tips

• **Visa Requirements**

Although U.S. citizens do not need a short-term visa while visiting the Czech Republic, the Czech authorities do require a visa for working purposes, study, and general stays over 90 calendar days. All visas must be issued by Czech Embassies or Consulates abroad, and cannot be obtained subsequently after arrival. Since the processing time may be very long in some cases, business travelers seeking temporary residence in the Czech Republic should contact their respective Czech consular offices as soon as possible.

Important Change!

Beginning on April 1, 2001, Canadian citizens and holders of Canadian passports must obtain a visa before travelling to the Czech Republic.
