



### FEASIBILITY STUDY

To test the proposed solutions and/or to be able to tailor-make them.

### COOPERATION ACTION PLAN

To to consult in more detail selected proposals with local partners and design a partnership modality



### SOLUTIONS IMPLEMENTATION

Introduction of new production processes, training of local workforce reimbursement of legal and translation services and capacity building of local suppliers.
