Rules for entry and return to the Czech Republic (as of 27th December 2021)

third-country nationals who do not have any residence permit issued by the Czech Republic or a long-term visa or long-term or permanent residence permit issued by other EU+ country

third-country nationals who have a short-term visa issued by the Czech Republic before 11th May 2020 or short-term visa issued by other EU+ country or travel to the Czech Republic in visa-free regime

Third-country nationals, who do not have any residence permit issued by the Czech Republic or a long-term visa or a long-term or permanent residence permit issued by other EU+ country, or who are not residents of countries with a low risk, are not allowed to enter the Czech Republic. There are several exceptions from this ban that are listed in the part II. / 1. of the MoH Protective Measure.

Travellers from all countries have an obligation to fill in the Passenger Locator Form before the arrival.



There are several exceptions from the obligation to fill in the Passenger Locator Form or undergo testing. All rules and exceptions can be found in the Ministry of Health Protective Measure.



A list of countries with a low, medium and high risk of Covid-19 transmission can be found here. A country listed in neither list of countries is considered as a country with a very high risk of Covid-19 transmission.



vaccinated persons - 14 days after the application of the last dose - according to these rules:

vaccinated in the EU+ - it is necessary to have an EU digital COVID certificate

exception from both tests:

• vaccinated outside of the EU+ - it is necessary to have an EU digital COVID certificate or a written confirmation which is published on the Ministry of Health website; only vaccinations approved by EMA or products producted in compliance with the patent of the approved vacctinations are accepted

persons meeting conditions of vaccinated persons who recieved also a COVID booster shot

Rules for testing:

Testing before entering the Czech Republic:

- 1) PCR no older than 72 hours
- 2) antigen no older than 48 hours

Testing after arrival to the Czech Republic - between 5th and 7th day after the arrival; until receiving I a negative result of a test it is obligatory to wear a respirator outside of the accommodation.
