

# Security Implications of Climate Change in South-Eastern Europe Contributions to the region's climate resilience by the OSCE as well as by Czechia

Side event organised on the occasion of the Czech Presidency of the Council of the European Union and the 30<sup>th</sup> anniversary of the OSCE Economic and Environmental Forum held since its initiation in 1992 in Prague

Both policy frameworks and practical examples for action from the South-Eastern European region will be presented. (5 7 min)

While climate change does not directly cause conflicts, it has a number of indirect implications on security, which is why climate change and its implications for security have been increasingly discussed at the international level. The adoption of the OSCE Ministerial Council Decision No. 3/21 "Strengthening Co-operation to Address the Challenges Caused by Climate Change" in 2021 in Stockholm has been a major breakthrough for the OSCE and the international community in recognising this link between climate and security and need to mitigate its worst effects. Furthermore, the OSCE's extra-budgetary project "Strengthening responses to security risks from climate change in South-Eastern Europe, Eastern Europe, the South Caucasus and Central Asia" aims to enhance regional co-operation in addressing climate-related security risks. The Czech Republic is one of the voluntary contributors to this project, focusing on its programming in South-Eastern Europe.







The topic of disaster risk reduction (DRR) and resilience in the context of fragility and climate change is one of the key priorities for the Czech EU Presidency within the humanitarian-development-peace nexus, based on the 2030 Agenda for Sustainable Development, the UN Framework Convention on Climate Change, the Paris Agreement, the Sendai Framework for Disaster Risk Reduction and other global initiatives such as the OECD/DAC Recommendation on the Humanitarian-Development-Peace nexus (triple nexus). One of the regions that the Czech Republic supports in this context is South-Eastern Europe.

During the side event, the participants shall be informed about the current results and future plans of the above-mentioned OSCE project, as well as relevant activities of the Czech Republic in this area, in both cases with a particular focus on the South-Eastern European region.

### The side event shall address the following questions:

- How does climate security impact humanitarian challenges and development progress and how does it inhibit peace?
- What are the specific examples of how the OSCE's activities in the field of climate change and security in the South-Eastern European region contribute to strengthening climate resilience and implementation of the global policy framework highlighted above?
- What might be the practical implications of the OSCE project for the strengthening of regional co-operation?
