We attach you here by a copy from the letter of the Syrian Arab Organization for Standardization and Metrology, No.1660/S/H/A, Based on the Legislative Decree, including the Documentation of Contract No. 5/2010 concluded between the Syrian Arab Organization for Standardization and Metrology and SGS Co., and contract No.6/2010 concluded among the Organization and the French / Bureau Vertas / Co.

Also, all the importation requests effective from September 1st 2010, of the Covered commodities in accordance with the index No/1/ of the above mentioned contracts, will be strictly prohibited from entrance into the country before they are fully subjected to the Program of Conformation and Materialization, in addition to the attachment of the Certificate of Conformity, and the certificate of Materialization from the price and origin presented by either of the two above mentioned companies in the country of origin before its entrance to Syria as an implementation to the decree No. 28/2010.

Kindly be advised, work in accordance with its contents, also according to the other effective regulations.
